Minutes of Meeting

- 1) Approval of Agenda G Wach called the meeting to order at 12.25 p.m. E Kosters moved, J Payne seconded, that the agenda be approved. No objections.
- Approval of minutes of 2 February, 2013, Annual General Meeting, Dartmouth, NS C Stanley moved, P Ryall seconded, that the minutes of the 2013 Annual General Meeting be approved as circulated. No objections.

Report on Colloquium online registration and payment system AGS goes 21st century!

The Local Organizing Committee of the 2013 AGS Colloquium consisted of myself (then president), Grant Wach (then president-elect) and Bob Ryan. We realized that the pool of AGS volunteers is not likely to increase in the near future. Thus, anything that can save precious volunteer time should be of benefit to the society. We researched the market tor companies that provide conference registration services and found an American company, Event Rebels (www.eventrebels.com) that appeared to be able to provide us with the required service for a very reasonable fee. We hired them to provide the online registration system for the 2013 Colloquium. The expense was CAD\$600.00. The registration system they provided was tailor-made, simple and fast. In addition, their help and support was excellent. AGS has a dedicated account manager who has never taken more than 2 hours to answer a question. The system spits out any (bookkeeping) report in seconds. It also generates name tags and receipts and automated registration replies etc. Volunteer-time reduced to manageable for anyone.

This year we decided to add online payment. The reason for doing so is twofold:

- 1. it's safer. Last year I personally hm1ded Nelly the unlocked cash box with ca. \$3000 in cash and more in cheques and she had to walk across a parking lot in Dartmouth. I didn't feel that it was right to expose Nelly to the risk of getting robbed and possibly injured because of AGS's antiquated business manners.
- 2. last year we had about 7 American registrants and 2 or 3 from Calgary. These people expect to register and pay online. The Americans didn't have Canadian cheques and had to hunt for a cash machine for cash. Not very 21st century. Doesn't look professional.
- 3. Some long-time AGS attendants had developed a tendency to show up with 10 students in tow without having registered ahead of time. This makes predicting number of attendants hard and you get endless discussions about whether someone qualifies for the early bird cut-off date, etc.

Event Rebels provides service for online registration and payment as well, for an additional \$250. In order to establish online payment for the colloquium, AGS had to create a PayPal business account. The PayPal business account is linked to the AGS bank account and gives AGS the opportunity to put buttons on the website for all other products that we sell: *Atlantic Geology*, geologic highway map, Last Billion Years, DVDs, field trips, etc. It costs AGS \$30/mo to have this account. Especially the AG editors were very much in favour of setting this up. It took a while to set up the Pay Pal account, but it's now running smoothly. The Canadian Pay Pal customer agents are incredibly helpful and accessible. Event Rebels can also build in abstract submission. This costs an additional \$800. We decided not to go there this year because Rob Raeside said he could handle the abstracts easily. It's something to keep in mind for subsequent years, depending on the Local Organizing Committee.

In conclusion: this experience has been extremely positive to date and very affordable in addition.
